

SelfMaker Smart Solutions Business Promotion Code by an independent partner.

I. Responsibilities:

The user of the affiliate program organized by Selfmaker Smart Solutions, which works on the <http://selfmakersmartsolutions.com> platform, acknowledges and is obliged to:

1. At the very beginning of each business presentation inform that he is an independent partner of the company.
2. Provide reliable and honest information about Selfmaker Smart Solutions and SelfMaker, as well as, the method of selling tokens via the www.selfmakersmartsolutions.com platform in particular.
3. Inform about the lack of a guarantee of profit and the existence of risk.
4. Inform that there is no need to invite new users.
5. Do not use misleading, unfair practices and trade.
6. Inform the users about their sole responsibility for the loss of access data to the mobile application, including private keys.
7. Present various scenarios for the future value of tokens: positive, neutral and negative.

II. It is forbidden to:

1. Guarantee of profit as it depends on the income generated by the SelfMaker group.
2. Guaranteeing the future price of the token, as it depends on the results generated by the SelfMaker group, as well as, the demand for the token after the fundraising ends.
3. Using SelfMaker partners for promotion, because the use of the partner's logo or name for promotional activities is always associated with obtaining the consent of the partner.
4. Using information about the company's contracts with third parties, aside from those provided in official materials and on the company's official channels.

5. Using the visit of the Prime Minister, Mr. Mateusz Morawiecki at the SelfMaker headquarters, as well as, his image to promote the company. Providing false information that the company was supported by the Polish government.
6. Using false information about the company.
7. Create promotional materials in a language other than English.

Violation of any of the points may result in immediate exclusion from the affiliate program by blocking the account of an independent partner not complying with the code of conduct and project regulations.

Violation of the points of the code 3), 4) and 5) may result in claims of companies and persons whose logotype, name or any confidential data concerning contracts have been used.

III. Recommendations:

1. It is recommended that you only use Selfmaker Smart Solutions advertising materials from <http://selfmakersmartsolutions.com> and from the official social channels of the SelfMaker group companies.
2. When creating your own advertising materials, it should be emphasised that you are an independent partner of the company. You should keep extreme caution and carefully check whether the newly created material complies with the above code and with the Selfmaker Smart Solutions terms and conditions available at: https://www.selfmakersmartsolutions.com/media/docs/Selfmaker_Smart_Solutions_Terms_and_conditions_10082020.pdf
3. Example of the right and the wrong conversation:
 - a) How may you promote the project?

I have a proposal for you to join an international project in which you can become a token holder of a company in the United Arab Emirates. By making an investment, you will acquire tokens and obtain the status of a token holder. A token holder is a person who has the right to participate in the profits achieved by the company, something like a dividend and a shareholder. The whitepaper is a compilation of the most important information about the project, read it carefully. If you are interested in an investment, register on the platform, if you have a problem, I will help you in this regard, but you have to do the registration by yourself. You may be interested in the company's affiliate program, but remember that you don't have to invite anyone or do anything like that.

b) How you can't promote the project?

I have a proposal for you to join the Polish project in which you can become a shareholder of the Polish company SelfMaker. By making an investment, you will acquire tokens as securities, which are the equivalent of shareholders / shares in this company. The investment is safe and risk-free, for sure. Whitepaper is an issue prospectus, but you don't even need to read it, I'll summarize the most important things for you. The best thing to do is to register an account on the platform, you will give me money in cash, and then I will buy tokens for you. If you like it, we will organize another meeting for other investors, and if they invest, you will get a commission. It's worth inviting new people to the project, that's all you really have to do, then you'll get a commission just for inviting someone.
